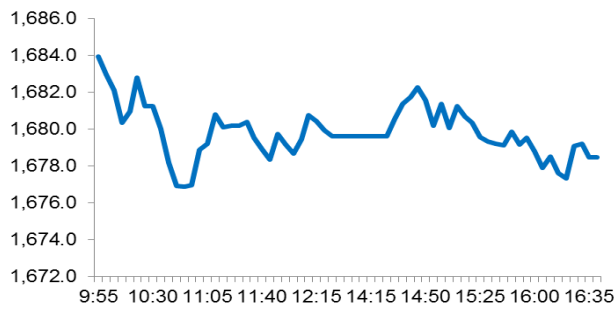

Central Plaza Hotel (CENTEL TB)	<p>Central Plaza Hotel has confirmed a Jul 2023 opening date for Centara Grand Hotel Osaka, its debut property in Japan. The project recently completed its topping-off event and construction is progressing – a 35-storey structure has been completed as work nears the halfway point on the timetable.</p> <p>Upon completion, Centara Grand Hotel Osaka will feature 515 premium rooms.</p> <p>Located on Namba Street, the hotel will be an ideal destination for family, leisure, and business travelers. CENTEL's foray into Japan highlights the group's strategic goal of becoming a Top 100 global hotel operator within five years with a portfolio of roughly 200 hotels and resorts, up from 89 properties at present. <i>(Bangkok Post)</i></p>	<p>The hotel is a JV project with CENTEL holding a 51% stake. The remaining 49% is held by two Japanese partners. We believe Centara Grand Hotel Osaka will be consolidated and help support earnings growth next year when international travel strongly rebounds after the COVID-19 pandemic eases.</p> <p>Meanwhile, CENTEL's plan to double its hotel portfolio may focus on managed properties rather than owned and JV projects. For its 2023 pipeline, its hotel in Japan will be the only JV property. The remaining seven hotels with a total 1,924 rooms in three countries - Thailand, Vietnam, and Laos – are all under management contracts. Synergies with parent Central Group and its companies – to manage hotels inside retail-led mixed-use projects in Thailand – may support this expansion plan. As the strategy is an asset-light one, the management fees may strengthen CENTEL's recurring income in the longer term. Still, we think the group may need time to ramp up the portfolio and deliver material earnings contributions from the managed hotels.</p> <p>We maintain the view that CENTEL's diversified food unit's performances may be close to pre-pandemic levels and will start returning to the black in 2022. A recovery of its hotel operations may support a jump in earnings from 2023 onwards and make the group's longer-term valuations attractive. We forecast a core profit of THB323m in 2022 (2021: THB1.78bn core loss) before seeing a 391% jump to THB1.59bn in 2023. We retain our call and TP on CENTEL.</p>	NEUTRAL, TP: THB33.00
