Company Update

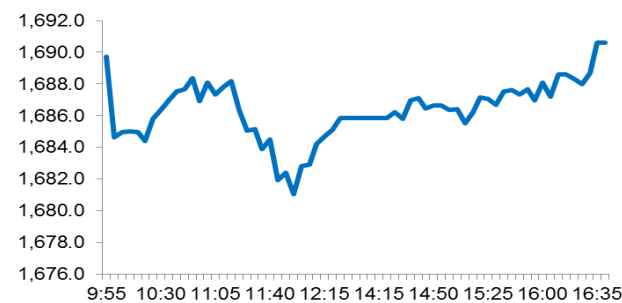
Stay NEUTRAL, new DCF-based THB2.93 TP from THB3.00, 4% downside and >6% yield. We believe Dynasty Ceramic will be another key player that can partially mitigate the impacts from the COVID-19 situation and rising energy costs by increasing the ASPs of its products portfolio. This implies its key strengths as a market leader, especially in low- to mid-end markets, while relying heavily on its own network of retail outlets. In spite of the limited share price upside, we maintain our call on DCC given its handsome dividend yields.
