Recovery Ahead With Tight Supply And High GRM Company Update

Maintain BUY and a THB4.50 TP, 31% upside with c.6% FY22F yield. IRPC's refinery business is set to perform well, supported by higher GRM and better utilisation rates. The EU has set an embargo for Russian imports – which should increase supply tensions and keep oil prices high. As such, IRPC should record a strong GRM in 2Q22.


