Revenue Set To Peak In 3Q; Still BUY

Company Update

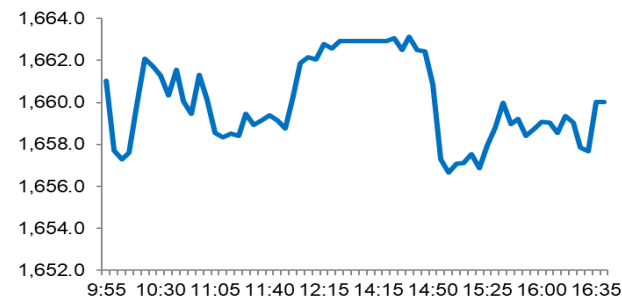
Maintain BUY and TP of THB24.90, 20% upside with c.5% FY22F dividend yield. Supalai can be regarded as a major developer that is well-prepared to deliver solid sales in the low-rise project segment. It is also primed to ride on the possible upturn in Thailand's condominium market. Although there are concerns over the developer re-selling its treasury stock to the open market, its valuation looks undemanding, ie trading at a single-digit P/E.
