Strong Outlook Ahead, Positives From TIP U/G

Trading Idea

FV of THB19-22 based on 15-17x FY22F P/E. We are optimistic on Asian Sea Corp, given that it is likely to recover from COVID-19's impact – boosted by 2Q22/2H22's demand recovery – and is on track in terms of potential businesses like pet care for long-term growth. The THB's depreciation should also enhance export growth while positive trends from Thailand's trafficking ratings upgrade should enhance product awareness and pave the way for seafood sales price increases, in our view.


