

BDMS uses the environmental management policy BDMS Earth Healthcare: Building eco-mindset, designing better environment, moving to green business, and sustaining social engagement. All its subsidiary hospitals perform regular environmental assessments according to the regulations. It has safe waste management and storage, ie hazardous materials and waste management plan, test spill kit drill, and spill incident reports.

# **Bangkok Dusit Medical Services** (BDMS TB)

### Seek Stronger 2H Outlook; Maintain BUY

- Maintain BUY and DCF-based THB36.50 TP, 20% upside and c.2% yield. 1Q23F earnings is expected at -4% YoY, +7% QoQ as it enters a low season in 2Q23F, before seeing stronger momentum in 2H23F. Still, we are positive on Bangkok Dusit Medical Services' growing international and domestic patients due to a higher demand for complex disease treatments and its ongoing business expansion, which may result in 2023F-2024F core profit at 6-7%.
- 1Q23F preview. We expect BDMS to post 1Q23 core profit of THB3.44bn (-4% YoY, +7% QoQ). Lower profit margin may have led to the YoY drop, while improving revenue and opex-to-sales ratio may likely support the QoQ growth. Its topline is expected at THB24.48bn (+7% YoY, +4% QoQ), driven by the price intensity together with strong growth from Thai and fly-in foreign patients. The foreign patient revenue mix may improve to 29% (1Q22: 22%, 4Q22: 27%) led by patients from the Middle East and Thailand's neighbouring countries. Still, EBITDA margin may shrink 2.4ppts YoY from a high base but slightly increase 0.3ppts QoQ to 24.5%. Bed occupancy rate may rise to 72% this quarter, up from 69% in 4Q22 thanks to Thailand's full re-opening, but it could likely still be below 80% in 1Q22 when BDMS attained higher margins from treatments provided for the Omicron variant – COVID-19 revenue mix accounted for as much as 18% (4Q22: 2%, 1Q23F: c.1%). Its opex-to-sales ratio may go up by 1.3ppts YoY to 18.8% mainly from higher personnel-related expenses.
- Seek stronger 2H23F outlook. 1Q23F bottomline may account for 25% of 2023F. We currently expect a slight YoY earnings growth for 2Q23F from higher patient volume but sluggish profit margin due to a high-base COVID-19 revenue mix of 13% in 2Q22 and opex hike. QoQ, it may decline on a generally low season amidst Ramadan and the Songkran holidays. We are more upbeat on the company's 2H23F growth momentum, to be driven by the ramping up of Chinese patients, back-to-normal foreign patient revenue mix to be partially supported by new source markets (ie Saudi Arabia), rising utilisation of three new campuses to be launched this year, and a lower base of COVID-19 revenue mix last year.
- Minimal benefit from social security scheme's higher payment. The Social Security Office (SSO) approved on Monday to raise the contribution of fixed capitation payment for its affiliated hospitals by 10.2% to THB1,808 per registered member pa, from 1 May 2023. We believe this will be positive to the overall Thai healthcare sector. However, for BDMS, we expect <1% earnings upside on having a minimal c.3% revenue mix from SSO patients.
- Maintain forecasts. We expect 2023F-2025F core profit to grow 6%, 7% and 7%. 2023's growth is based on 6% revenue growth (within BDMS' 6-8% guidance range), stable bed occupancy rate vs 2022's 73% (including COVID-19 treatment), and stable EBITDA margin of c.24%.
- Valuations. Based on our proprietary methodology, we derive an ESG score of 3.7 and apply an 8% premium to our DCF-derived intrinsic value to arrive at our unchanged TP of THB36.50. BDMS is trading at 34-36x 2023F-2024F P/Es, ie an undemanding -0.75SD to -1SD.


Figure 2: BDMS' performance preview


