• BUY, new FY21 (Sep) THB74.00 DCF-based TP from THB72.00, 10% upside. We think an improving tourism and aviation outlook may support stock sentiment despite a possible North Terminal postponement. We expect smaller negative earnings in 2HFY21 and a return to profit in FY22.


**Local Aviation Sees Strong Improvement; BUY** 

- Suvarnabhumi Airport's (BKK) North Terminal expansion may be postponed. The Cabinet on Tuesday endorsed the National Anti-Corruption Commission's (NACC) proposal for Airports of Thailand prioritise THB12bn in expansion investments on BKK's two new terminals – East and West – first to raise total pa capacity by 15m passengers to 75m. The South Terminal should then be the next development to achieve an annual capacity of 120m passengers. NACC's recommendation: The THB41.26bn North Terminal (adding 30m passengers pa) may be re-considered as the last project once the East, West, and South Terminals are completed.
- Likely an overhang. This may be against AOT's plans and, according to local media, the Transport Ministry's wants to undertake the North Terminal's expansion first. AOT may now have to revise the project's schedule, or it may become an overhang. Yet, we do not think this will obstruct BKK's operations, as AOT's aeronautical activities in the next three years may be still be under a post-pandemic recovery. Also, the East and West Terminals expansions may be able to serve BKK's FY19 passenger levels of 64.7m. We also leave out the traffic rise from these terminals as earnings upsides. We believe its balance sheet will stay solid despite potential debt financing for capex and amidst tightened cash liquidity now.
- Local aviation sees strong recovery. AOT's latest flight watch for 1-20 Mar showed a strong improving momentum for local aviation post the late Dec 2020 COVID-19 resurgence here. This includes -33% (1-28 Feb: -65%) and -31% (1-28 Feb: -68%) YoY in flights and passengers. We think its domestic recovery may approach pre-pandemic levels by FY23, a year ahead of the international side. We expect stronger YoY growth magnitudes from a low 3Q-4Q21 performance base. The Government's latest approval for Phase 3 of the "We Travel Together" local tourism stimulus campaign, from May to August, may be a catalyst and boost flight numbers.
- Hence, we revise up FY21F-24F local passenger numbers by following its mid-February guidance. Hence, FY21F earnings are up to -THB11.27bn vs a THB11.56bn net loss, while FY22F and FY23F earnings are up 14% and 1% to THB4.34bn and THB22.47bn, a 5x spike. We expect its aeronautical activities will return to pre-COVID-19 levels by end 2023 (1QFY24).
- Keep BUY. We raise TP to THB74.00 based on the earnings upgrade. 2QFY21F's performance may be the weakest of the year, before gradually improving with smaller losses throughout 2HFY21. An earnings turnaround in FY22 may also support AOT's long-term outlook. As a first-tier tourism player, it is more likely that improving industry conditions may dominate stock sentiments. It remains our Thai hospitality sector Top Pick.
