Fair 1Q21 Presales; Downgrade To NEUTRAL

- **Downgrade NEUTRAL from Buy with unchanged THB8.40 TP, +3% upside and >5% yield.** Although likely that AP (Thailand) can perform its 1Q21 presales momentum to a moderately high degree – and help support our FY21F earnings – the current share price is approaching our TP. Therefore, we downgrade our call.
- **1Q21 presales are fairly good.** AP announced 1Q21 presales of THB7.97bn (+32% YoY, +5% QoQ). As expected, low-rise project presales dominated the overall numbers at 92% (+43% YoY, +5% QoQ). Condominiums remain under pandemic pressure and the company attempted to liquidate as many of its completed units inventory as possible. Therefore, this segment's presales declined 29% YoY. Compared to management's THB35.5bn (+12% YoY) FY21 presales aim, actual presales in 1Q21 accounted for 22% of this target. In our view, its 1Q21 presales are acceptable despite none of AP's highlighted projects being launched since the start of FY21. On a YTD basis, the company has launched only two low-rise projects – Apitown Chiang Rai and Apitown Ayutthaya – with a combined project value of THB2.3bn. Sales progress till now has not been exciting, at 10-15% of project value.
- **Stronger 2H21 presales anticipated.** There will be five small low-rise projects launched in 2Q21 with a combined project value of THB2.7bn. We expect no significant improvement in presales vs 1Q21's numbers. Yet, 3Q21 should provide AP good opportunity to boost presales to meet management's full-year target, as it is planning to resume the launch of three new condominium projects then, with another in 4Q21. We believe these four projects – with a total project value of THB14.2bn – may also face launch delay risks, especially if demand remains in the doldrums.
- **Earnings estimates maintained.** Apart from AP's recent presales performance, transfer momentum within this year will also be determined by two condominium projects under JV with similar presales progress of 70% – Life Asoke Hype and Life Ladprao Valley. Based on our observations, both projects can start their transfer process in July as planned. Accompanied with a current orderbook of low-rise projects worth >THB8bn to be recognised as revenue within this year, these two condominiums will help support our FY21 topline estimate of THB26bn. Although our revenue forecast is lower than management's target of THB31.1bn and also FY20's actual sales revenue, we believe topline downside is limited under the current circumstances. Nevertheless, we maintain our estimate of 16% YoY lower net profit in FY21 after AP's historical record high in FY20.
- **D/G NEUTRAL with THB8.40 TP.** Downside risks: High household debt and intense market competition. The opposite represents upside risks.

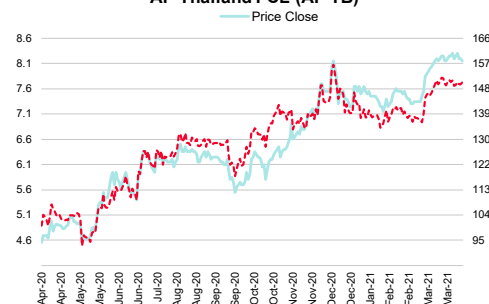
