• Maintain NEUTRAL and THB8.40 TP, 0% upside and >5% yield. Although 1Q21 should be another quarter for AP (Thailand) to show strong earnings growth both YoY and QoQ - mainly driven by revenue


from the low-rise projects segment - we retain our FY21F earnings forecast. This is because we expect the net profit momentum to soften in the following quarters. Also, the current share price has met our TP; therefore, we stick to our call.

- Another strong earnings prospects expected in 1Q21. We expect a 1Q21 net profit of THB1.3bn (+109% YoY, +37% QoQ), as AP will recognise a solid core revenue of THB8.8bn (+63% YoY, +17% QoQ) while GPM stabilises QoQ at a level above 31%. Sales revenue will be mainly driven by high orderbooks of low-rise projects worth c.THB8.35bn as of end FY20, while condominium developments - including Life Ladprao, Life Asoke-Rama IX, and Aspire Asoke-Ratchada - will play a minor role in contributing to 1Q21 earnings. All the aforementioned condominium projects have been consistently transferred since FY20.
- 2Q21 earnings to weaken to FY21's lowest quarter. AP's earnings pattern within FY21 will come to the low-ebb level in 2Q21, as the bulk of low-rise project orderbooks were recognised in 1Q21 and the company commanded fairly good presales of THB7.97bn (+32% YoY, +5% QoQ) during this period. Therefore, 2Q21 sale revenue will inevitably decline visà-vis FY21's highest quarter: 1Q21. We expect earnings to improve QoQ in 3Q21 and 4Q21, as AP plans to more aggressively launch new low-rise projects in 2H21 with 23 projects out of a full-year plan of 30. There are also two newly completed condominium projects under a JV with a Japanese partner that will start contributing revenue in 3Q21. Hence, we maintain our FY21 net profit estimate of THB3.5bn, or a 16% YoY decline.
- Chance to boost presales in 2H21. Although we expect AP to have passed the year's highest earnings in 1Q21, there is a high chance for the company to command strong presales momentum again in 2H21 - this is after AP showed moderate 1Q21 presales equivalent to 22% of its fullyear target. The company will resume the launching of new condominiums in 3Q21 (three projects) and 4Q21 (one project). However, the surge in COVID-19 cases in Thailand currently may postpone plans to launch these new projects - this is in case this round of the pandemic is not tamed soon.
- Maintain NEUTRAL. While AP is maintaining its solid growth momentum, especially in terms of presales, we believe the company cannot avoid this year's earnings decline when compared to 2020's high base. Therefore, the share price should trade at an 8-year mean average of 7.5x P/E at best. Downside risks to our call: i) High household debt, and ii) intensive competition within the industry. The opposite represents the upside risks.
