

Bangkok Chain Hospital (BCH TB)

Defensive With Attractive Valuations; Keep BUY

Maintain BUY and THB17.50 TP, 30% upside with c.2% yield. While the COVID-19 resurgence may put pressure on a medical tourism recovery and Bangkok Chain Hospital's pre-opening projects near Thailand's borders, its outlook should remain solid - supported by pandemic-related services and the government healthcare scheme (GHS) segment. The current valuation is still attractive, at a relative discount vis-à-vis its peers.

- Higher volumes, lower margins. Post resurgence of a new cluster in Samut Sakhon, which started to spread nationwide, the Government's proactive approach – aimed at fully supporting COVID-19 testing costs for all Thais (not limited to public hospitals only) - should result in higher demand for screening services. The change in the government payment scheme for testing services in October – from THB3,540 per case to THB2,300 – should lower the positive impact in terms of margins contribution to BCH. However, we still expect other COVID-19-related services - eg Alternative State, Alternative Hospital, and Organisation Quarantines – to be alternative revenue sources that should buffer topline downsides. But, we remain cautious on the temporary drop in regular patients traffic (ie trauma and respiratory cases), which will be driven by selective lockdowns and various preventive measures being reintroduced.
- Pre-opening projects need more time. The looming COVID-19 second wave from cross-border migrants should force the Government to reconsider again its plans to ease border restrictions and quarantine framework. We expect this to create a negative impact on Kasemrad International Aranyaprathet Hospital's pre-opening. This hospital is adjacent to the Cambodian border. The pre-opening phases of Kasemrad International Vientiane and Kasemrad Prachinburi – set to open in 1Q21-2Q21 - may also see delays or take more time to turn EBITDA profitable. This should also be another downside risk to BCH's short-term margins.
- Social Security Office (SSO) to still be the key driver. While we expect to see ongoing growth from the SSO segment – mostly driven by higher registered members from newly opening projects – the recent launch of free influenza vaccines for those insured under Sections 33 and 39 (aged over 50) and the 1-day surgery programme from the Social Security Scheme should also be the other revenue upside for BCH in 2021. We also remain optimistic on its mid-term outlook, which will be catalysed by the shift in patient traffic to the GHS during this weakened purchasing power period, and given the outstanding quotas still on hand.
- Outlook remains solid. BCH's core operations remain strong, with a welldiversified revenue structure and double-digit earnings growth prospects. While the cross-border patients segment needs more time to gain momentum, we remain positive on fly-in patients - this segment will gradually recover once vaccine distributions start in the developed nations.
- Keep BUY. BCH's outlook remains solid, with valuations looking relatively attractive vs the industry's - at 24x vs 50.7x. Key risks: Regulatory uncertainties and the delay in the healthcare budget's disbursement.
