

the same period last year, and lower QoQ on the resurgence of COVID-19 infections. We keep our view that it will see YoY profit growth in Q2, on a low base of sales and recurring income, with improving 2H21 momentum post COVID-19. Its valuation is still undemanding.
1Q21F results: A high-base effect. BJC delivered 1Q21 net profit of THB1.01bn (-21% YoY -25% QoQ), which was 11% below our forecasts –

yield. Berli Jucker's 1Q21 results were sluggish YoY on panic buying during

- 1Q21F results: A high-base effect. BJC delivered 1Q21 net profit of THB1.01bn (-21% YoY, -25% QoQ), which was 11% below our forecasts – as its topline and other income were 3% and 9% below our expectations. The sluggish performance was mainly due to declining sales and recurring income vs a 1Q20's high base, when its modern retail and consumer supply chains benefitted from households stockpiling prior to the national lockdown for COVID-19, while retail mall tenants at Big C stores were operating as normal. The QoQ drop was a result of seasonality effects, and a resurgence of cases in Jan-Feb 2021.
- Steeper drop in SSSG. Total sales were at THB32.5bn (-16% YoY, -7% QoQ) on decreasing sales of packaging, consumer, and modern retail supply chains. Big C's SSSG of -21.6% remained sluggish, impacted by the Government's co-pay scheme which has shifted customers to traditional retailers. SSSG for all its store formats were close to the average. Contribution from the low-margin business-to-business or B2B customers remained high at 12.3% of Big C sales vs 4Q20 (1Q20: 6%).
- Other income was down 18% YoY and 14% QoQ on lower rental income, and Big C suppliers' brochure and advertisement income. Rental income fell 19% YoY mainly on steeper rental rate discounts of c.10% given to Big C mall tenants (4Q20: 6-7%) affected by COVID-19's resurgence.
- **GPM improved slightly YoY.** BJC's GPM rose 0.2ppts YoY to 19.1%, as its glass packaging business benefitted from the downtrend in raw material prices and good cost management, as well as the consumer supply chain's improvements at most of its segments. GPM declined 0.6ppts QoQ on a declining momentum for aluminum can production and rising costs for the consumer supply chain (ie palm oil price hike).
- Lower effective tax rate of 10% vs 1Q20's 19% and 4Q20's 12% on tax privileges from its investments into packaging and consumer supply chains.
- Keep BUY. 1Q21 net profit accounted for 18% of our FY21F net profit estimate of THB6.6bn (+26%). We maintain our view that 2Q21F earnings may turn to YoY growth from a low performance base. An expected domestic consumption recovery in 2H21F may also strengthen its outlook.
- Key risks to our call: Further lockdowns or other restrictions by the Government to control COVID-19, a delayed recovery in consumer spending, volatile production costs, and an increase in opex.

การเปิดเผยการประเมินดัชนีชี้วัดความคืบหน้าการป้องกันการมีส่วนเกี่ยวข้องกับการทุจริตคอร์รัปชัน (Anti-Corruption Progress Indicators) ของบริษัทจดทะเบียนในตลาดหลักทรัพย์แห่งประเทศไทยที่ จัดทำโดยสถาบันที่เกี่ยวข้องซึ่งมีการเปิดเผยโดยสำนักงานคณะกรรมการกำกับหลักทรัพย์และตลาดหลักทรัพย์นี้เป็นการดำเนินการตามนโยบายและตามแผนพัฒนาความยั่งยืนสำหรับบริษัทจดทะเบียนโดย ผลการประเมินดังกล่าว สถาบันที่เกี่ยวข้องอาศัยข้อมูลที่ได้รับจากบริษัทจดทะเบียนตามที่บริษัทจดทะเบียนได้ระบุในแบบแสดงข้อมูลเพื่อการประเมิน Anti-Corruption ซึ่งอ้างอิงข้อมูลมาจากแบบแสดง รายงานข้อมูลประจำปี แบบ (56-1) รายงานประจำปีแบบ (56-2) หรือในเอกสารหรือรายงานอื่นที่เกี่ยวข้องซึ่งเป็นบุคคลภายนอก โดยมิได้เป็นการประเมินการปฏิบัติของบริษัทจดทะเบียนในตลาดหลักทรัพย์ แห่งประเทศไทยและมิได้ใช้ข้อมูลภายในเพื่อการประเมิน เนื่องจากผลการประเมินดังกล่าวเป็นเพียงผลการประเมิน ณ วันที่ ปรากฏในผลการประเมินเท่านั้น ดังนั้นผลการประเมินจึงอาจเปลี่ยนแปลงได้ ภายหลังวันดังกล่าว หรือรับรองความถูกต้องครบถ้วนของผลประเมินดังกล่าวแต่อย่างใด
