

Bumrungrad Hospital (BH TB)

Limited Downside, But Recovery Stays At Risk

- NEUTRAL, with new THB110.00 TP from THB125.00, 3% downside with c.1.6% yield. While the core outlook is highly sensitive to quarantine and vaccination policy developments, the focus shift towards the local market will remain Bumrungrad Hospital's key 2H20 challenge. While we retain our view that earnings will take at least two years to return to pre-COVID-19 levels, BH's valuation and net cash position should be a share price buffer.
- 2Q20 core earnings fell 93.9% YoY (1H20: -55% YoY) to THB44m, largely on a significant revenue drop from hospital operations that overrode BH's cost reductions. Total revenue fell 42.8% YoY to THB2.4bn, impacted by fewer fly-in patients due to international travel restrictions, hospital infection fears, and the nationwide lockdown. While the local and expatriate segments have shown some recovery signs in late 2Q – following the easing of the national lockdown – revenue from international patients are still in a deep decline trend, as border lockdowns remain in place.
- Management remains positive over the medical tourism segment's resumption pace whenever the Government decides to relax border restrictions. This is largely on BH's lengthy pending patients list on hand. The Government's Alternative State Quarantine (ASQ) programme's recent expansion to six hotels from two in August should help boost capacity to handle incoming travellers, but two new cases detected last week post the national lockdown's easing may generate negative momentum, which could result in the Government reconsidering entry plans for foreigners once more. We still weigh more towards the downside, expecting at least two years before medical tourism returns to pre-pandemic levels.
- While the attempt to roll out promotional campaigns eg the Buy 1-Get-1 Free check-up package, a c.20-50% discount on medical supplies and room rates, and all-inclusive prices on tertiary services should allow BH to draw in additional traffic from the local market, we believe this will start lowering 2H20's profitability margins. While plans to maintain the physician turnover rate is likely to limit further cost reductions, we think margins will be re-based to the new normal level until the medical tourism sector begins its recovery. Our FY20F-21F EBITDA margins are revised to 25.2% and 28.2% vs 31.2% and 31.3% previously. Despite the prospects of a local patient numbers recovery, we revised down outpatient (OPD) and inpatient (IPD) traffic to -15% and -30% vs -10% and -15% to incorporate the lack of fly-in patients. We also trim down OPD and IPD revenue intensity by 3% and 5% to incorporate BH's pricing strategies.
- NEUTRAL with lower TP. 1H20's dividend payout ratio was raised to 113% (c.50-60% earlier) to maintain DPS (THB1.15, c.1% yield) at 1H19's level. The share price's fall to the lower-bound levels of the 5-year mean already prices in such concerns, but a tightening quarantine policy or prolonged international restrictions that delays medical tourism's recovery remain downside risks. Upside risks: Better-than-expected local patient traffic from BH's promotions and entry ban easing imposed by the Government.


