Three out of Central Pattana's 35 retail malls had 80% closures of leasable areas: Central Plaza Mahachai, Central Plaza Rayong, and Central i-City (Malaysia) - the rest saw limited temporary tenant closures (20%) and 50-60% drops in traffic. Yet, we are optimistic on the re-opening of certain activities (eg fitness centres, spas, beauty clinics, educational centres, etc) in Bangkok from 22 Jan, which may indicate more relaxing of pandemic controls in the near term. Assuming COVID-19's resurgence here

Upcoming asset spin-offs. CPN Growth Leasehold REIT (CPNREIT TB, NR) announced plans last Thursday to invest in more two CPN leasehold retail malls with combined NLAs of 30,656sq m - Central Marina Pattaya and Central Plaza Lampang - with the total not exceeding THB5.67bn. We think this may act as short-term investment catalysts, given earnings upsides from possible one-off extraordinary gains from the asset sales in 1H21. Proceeds should financially support its new retail developments. We expect CPN's net D/E ratio to stay at 0.1-0.2x in 2021-2022.

- We revise up 2020F core profit by 8% to reflect the improving operations in 2H20, and trim it 4% and 1% in 2021F-2022F to reflect the impact of COVID-19's second spread domestically. We assume an average rental rate discount of 15% and 10% for 2021 and 2022. We expect CPN's 2021-2022 solid core profit growth at 28% and 18%. Apart from a low earnings base, it will mainly be driven by the opening of new malls, launch of new residential projects (c.10% of total revenue), and CPN's strength on opex controls, in our view, which can help boost core profit margins by 2ppts pa.
- Keep BUY. We roll over the DCF-based TP to FY21F's THB66.00. Having a long-term position in the stock is still attractive, in our view, with justified 24x FY21F and 19x FY22F P/Es. Earnings may return to pre-pandemic levels next year, in tandem with a recovery in foreign visitor numbers. Key risks: Delays in new project openings, extension of the pandemic, and weaker-than-expected domestic consumption.




Figure 1: CPN's DCF valuation
