CH Karnchang (CK TB)

Time For Smashing New Bids; Keep BUY

- Keep BUY and SOP-based THB22.50 TP, 13% upside with 1.8% yield. As the time for the new infrastructure bid cycle is approaching, especially for mass rapid transit (MRT) projects, we expect construction players with strong potential to post wins. CH Karnchang especially should be more interesting - in terms of success in adding new orderbooks.
- Weak earnings to continue in 2Q20. After CK booked a 1Q20 net loss of THB112m due to a contribution loss from CK Power, we expect the tough situation to continue in 2Q20. The company will be under pressure from slower construction revenue, in our view. This is in tandem with lower orderbooks on hand, our anticipation of a 2Q20 earnings loss by CK Power (based on the ongoing drought at the Xayaburi Hydropower project), and slim profits shared from Bangkok Expressway & Metro (BEM TB, BUY, TP: THB11.50). The latter is based on the lowest expressway traffic and Blue-Line MRT ridership levels booked in April and May. However, there should be a supporting factor: THB232m in dividend income from TTW, which ought to be recorded in 2Q20.
- Full of hope for new orderbooks. Management is expecting a new cycle of orderbook accumulation to begin soon, as there are a few highlighted infrastructure projects slated for bid launches from 3Q20. Among these, we believe CK - in partnership with BEM - will make the Orange-Line MRT project its first priority. This is based on the two companies' joint experience in constructing and operating underground MRT routes. The second priority: The construction of the Purple-Line MRT extension, as Phase 1 of this line is currently operated by BEM under concession terms. CK is also focusing on two new double-track railway project routes with a combined construction value of THB126bn, given its satisfaction with a 7-8% GPM for the previous construction of a double-track route.
- Orderbooks on rising expectations. Based on a 25% chance of winning the civil construction contracts for the Purple-Line MRT extension and two new railway routes, CK's current small orderbook - totalling c.THB35bn should be enlarged to a >THB100bn historical high by next year. Prospects should be brighter if its consortium can win the Orange-Line MRT bid, which can take its orderbook to a new high: >THB200bn. We believe CK must land new abundant orderbooks to boost revenue growth from FY21 onwards, after core topline declined over the past three years.
- More demanding at bid time. Our SOP-based THB22.50 TP implies 25.2x P/E - equivalent to +1SD above the 10-year mean average. This is appropriate under the current situation, ie the approaching new infrastructure project bids cycle.




