Top PickCH Karnchang - BUY THB20.30

Overweight (Maintained)

 Maintain OVERWEIGHT on the sector, and CH Karnchang as our Top Pick. Although construction activities nationwide have been halted for a month, due to Government-imposed restrictions to control the pandemic, we see positive opportunities ahead for the sector – especially in terms of new infrastructure bids in 3Q21. CH Karnchang is likely to win these upcoming infrastructure bids, in our view.

Great Opportunities In 3Q21; Still OVERWEIGHT

- 3Q21 to be the highlight of FY21. During the quarter, there will be two major bids for infrastructure projects: i) The re-launch of two construction contracts (No.1 and No.3) for Rama III-Dao Khanong after the previous round's lowest bidders were disqualified; and ii) the Purple-Line MRT extension (Taopoon-Ratburana), which started its Terms of Reference (TOR) distribution period on 5 Jul.
- Re-launch of two expressway contracts. While construction works for contract No.2 of the Rama III-Dao Khanong expressway, by China Harbour Engineering's consortium, and CH Karnchang's contract No. 4 have progressed in line with the master plan at 15% and 30%, the Expressway Authority of Thailand (EXAT) will re-launch the bids for contracts No.1 and No.3. The bidding results for these two contracts were cancelled in FY20. The TOR distribution period will end on 30 Jul, and candidates will submit their proposals to EXAT on 2 Aug. To eliminate bidders' concerns over cost risks, EXAT has revised up the indicative prices for both contracts by 5-6% to reflect the sharp rise in steel prices. Although the two contracts can be regarded as small-sized construction works, at THB7.4bn per contract, we expect both CH Karnchang and Sino-Thai Engineering and Construction (Sino-Thai) to participate actively. We think CH Karnchang has a strong interest to win either one of the contracts, as it is working on contract No 4, which is the construction works for bridge across the Chaophraya River. For Sino-Thai, the opportunity is timely for it to revise its proposed pricing levels after being the highest bidder for all three contracts (No 1-3) in the previous round.
- Purple-Line MRT extension on schedule. The most exciting bid for FY21 should be the Purple-Line MRT extension, with a total project value of THB79bn. As this bid started its TOR distribution period yesterday (5 Jul 7 Oct), proposals from candidates should be submitted by October. We maintain our expectation that the Top-3 largest construction companies, including two under our coverage, will focus on bidding for four underground contracts, and mid-sized contractors will be eyeing the elevated section. For track works, only a few construction companies have relevant experience. Most importantly, we anticipate that all six contracts will be fairly distributed to all large construction players.
- CH Karnchang still our Top Pick. In our view, CH Karnchang, with a low orderbook on hand, is looking to secure new jobs, while Sino-Thai, with its abundant orderbook, is seeking new high-margin projects to enhance its currently low GPM. Based on our expectation of fairly-distributed wins for all large players in the Purple-Line MRT project, and the high chance of CH Karnchang winning expressway contracts, we think a turnaround is likely for the group's orderbook from only THB30bn currently.
