Top Picks Target Price CP All (CPALL TB) - BUY THB77.00 Home Product Center (HMPRO TB) -THB17 00

NEUTRAL; Top Picks: CP All (CPALL) and Home Product Center (HMPRO). We are optimistic on the Government's further relief measures, which should help boost consumption throughout 2H21F. We expect Berli Jucker (BJC) and CPALL to indirectly benefit from the latest co-pay scheme, and see short-term windfalls from the live broadcasts of the Euro 2021 soccer tournament. The shopping cashback scheme may support Home Product Center (HMPRO) and Siam Global House (GLOBAL) sales. Retailers' 2Q21F earnings should deliver YoY growth from a low base, despite being the weakest quarter.

New Co-Pay Scheme Well-Registered

- Third-phase co-pay measure. Registrations for the third phase of the Finance Ministry's co-payment subsidy scheme kicked off on Monday. It covers 31m eligible recipients with a THB93bn government budget - bigger than the first two phases which covered a combined 25m people with a THB52.5m budget. Under the current scheme, participants will get a 50% daily discount - capped at THB3,000 per person - at participating shops and stalls, from 1 Jul to 31 Dec 2021. The Government expects the project to bring THB186bn cash into the economy. We learnt that 23.7m people had signed up on Monday, leaving 7.3m slots available, and expect that it will be fully subscribed in the next few days, as the scheme will help support recipients' living costs during the current severe third wave of COVID-19.
- BJC and CPALL as beneficiaries. We still expect the co-pay scheme to continue indirectly supporting staple retailers' SSSG throughout 2H21F, as traditional retailers participating in the campaign may restock their inventories more frequently. The scheme includes BJC's modern retail supply chain (Big C Supercenter) and CPALL's Siam Makro cash-and-carry business. We also believe BJC and CPALL will see short-term benefits from the live broadcasting of the Euro 2021 soccer tournament, from 11 Jun -11 Jul, as it may boost demand for food and beverages. Note that Big C contributes two-thirds of BJC's topline and c.55% of its profits, while Siam Makro contributes c.37% of CPALL's total sales and c.30% of its profits.
- Discretionary retailers to gain from shopping cashback scheme. The Government also aims to launch registrations for the "Ying Chai Ying Dai" campaign from 21 Jun 2021. The campaign will offer cashback e-vouchers not exceeding THB7,000 to participants who spend up to THB60,000 from 1 Jul - 30 Sep. It targets 4m registrations and is expected to generate c.THB268bn cash to the economy, or widen the GDP by 0.8%. We expect the scheme to attract high-income earners and spur revenue among discretionary retailers in departmental stores and home improvement platforms (HMPRO and GLOBAL) in 3Q21F.
- Still NEUTRAL. While the ongoing third wave of COVID-19 infections may dampen the sector's 2Q21F momentum, we still expect retailers to deliver positive SSSG and bottomline profit growth from last year's low base mainly the non-food/discretionary players and shopping malls - when the 1.5-month national lockdown in Apr-May 2020 caused the temporary closures of their stores. We expect stronger 2H21F sector earnings vs 1H21F, to be mainly driven by improving consumer confidence and a recovery of outdoor activities, in tandem with the national vaccine rollout. CPALL and HMPRO are our Top Picks among Thai retailers.
