Home Product Center (HMPRO TB)

Good Start For Earnings Growth Rebound; Keep BUY

- Maintain BUY and THB17.00 TP, 21% upside and 3% yield. In 1Q21 Home Product Center may deliver positive SSSG for the first time in six quarters and a YoY profit growth for the first time in four quarters, due to improving sales and recurring income. The third COVID-19 wave may dampen its earnings momentum yet, we expect a favourable YoY growth in 2Q21F as physical stores are still opened vs being shut down as was the case last year. Valuation is still undemanding.
- SSSG to turn positive for the first time in six quarters. We expect HMPRO to deliver for the first time since 2Q19 a positive c.1% YoY average SSSG in 1Q21. HomePro sales may be stronger in March, in tandem with the recovered consumption confidence in Bangkok, despite a second wave of COVID-19 and the ongoing weak sentiment in tourism-related provinces. Mega Home construction material stores (c.15% of total sales) may benefit from rising steel prices (c.2% of total sales) and the improving demand in farm-related provinces, following the agricultural products price hike. HomePro Malaysia operations (c.2% of sales) may post a favourable c.9% YoY SSSG vs a low base for the same period last year.
- 1Q21F preview. We expect Homepro's 1Q21 net profit to reach THB1.32bn (+4% YoY, -15% QoQ). We estimate the YoY growth in Q1 to be driven by: i) total sales growth of 3% YoY, to THB14.91bn; ii) rental income growth of 4%; and iii) an 11% growth in service income, vs the the same period last year with the temporary closure of physical stores in late-March 2020. GPM may be slightly lower by 0.1ppt, to 25.6%, on an expected increase in low-margin electrical appliance sales prior to summer. The shipping container shortage may obstruct its inventory sourcing, and the online sales mix may remain stable at c.5%. NPM could widen by 0.1ppt, to 8.8%, on the improved recurring income. A seasonality effect may lead the QoQ drop.
- 2Q21's outlook: Strong growth remains. The ongoing third spread of the pandemic may be negative to HMPRO's momentum on customer traffic, sales, and profit margins. Nevertheless, we expect to see a robust YoY earnings growth from an extreme low base in 2Q20. Its physical stores are currently opened, which support its sales and service income growth. Online sales may ramp up QoQ this quarter, due to an increased demand for work and cooking-at-home activities. Its marketing event "HomePro Super Expo" on 2-6 Apr may also act as another sales support. Rental income is likely expanding rental discounts may be steeper than c.20% in 1Q21F, but a lot better than the rental waivers from 2Q20.
- Maintain a 17% earnings growth for 2021F. We maintain HMPRO's FY21-FY23 forecasts, and expect FY21 core profit to grow 17%. This is based on conservative assumptions of: +3.5% SSSG, +0.4ppts GPM increase, and a rental income recovery to 16%.
- Keep BUY and FY21F DCF-based THB17.00 TP. Its current valuation of 31x P/E (-0.5SD) remains undemanding although its profit growth rate may rebound close to 2018-2019 levels. EPS growth in 2021 may be a laggard vs domestic home improvement peers' >20%, but ROE remains superior.






