Get Set For The "Special Tourist Visa"

- Stay UNDERWEIGHT on tourism, no sector Top Pick. We expect the Special Tourist Visa programme, which allows foreigners to travel anywhere within Thailand - post the 14-day state quarantine - to be costly and not attract visitors from the country's major source markets in East Asia. In addition, the Government's campaign to boost domestic tourism has generated minimal benefits to hoteliers. Negative earnings could continue in 2H20F, and it is too soon to expect back-to-normal conditions in the industry.
- A new foreign tourist re-entry plan. The Centre for COVID-19 Situation Administration, on Wednesday, gave the green light for the proposed "Special Tourist Visa", which will allow international tourists to go anywhere within the kingdom for up to 270 days, after 14 days in state guarantine. The program may replace the "Phuket Model" which involved travellers flying directly into Phuket. We expect the new plan to be passed to Cabinet for further approvals in a few weeks, and implementation by around 4Q20.
- First step towards recovery. The scheme may provide a short-term positive sentiment towards the Thai hospitality sector, in our view, as the re-entry plan would cover the entire country. It could help resume foreign tourist arrivals, after having zero visitors for six consecutive months since April. However, the lengthy stays allowed under the programme may not attract Thailand's key source markets in East Asia (c.67%), given that their average stays are only about seven days. Only small groups of high spenders from long-haul destinations in Europe (17%) and the Americas (4%) may benefit, as they average at 17 days and 15 days per stay. We do not expect to see a big jump in arrivals, as the resurgence of COVID-19 cases continues globally, and flight operations remain very limited.
- 2020-2021 visitors and receipts still under pressure. We now expect • total foreign arrivals and receipts of 10.3m and THB512bn (-74%) this year, but see further downside for the numbers to 7m visitors and c.THB350bn in receipts. The outlook for 2021 also remains unstable. Meanwhile, listed Thai hotels may minimally benefit from Government initiatives to boost domestic tourism. As of Wednesday, only 19% of the total 5m room nights offered under the 3.5 month- "We Travel Together" subsidy program were redeemed, since mid-July 2020. This may be insufficient to offset the slump in foreign visitors, which is the local tourism industry's key source market.
