# Kiatnakin Phatra Financial Group

(KKP TB)

## Short-Term Catalyst From Motor Expo; Keep BUY

- Keep BUY and THB66.00 TP, 10% upside and c.6% FY22F yield. Apart
  from boosting car sales, the Thailand International Motor Expo in December
  should help bolster new hire purchase (HP) loan bookings and positive
  sentiment for banks, especially Kiatnakin Phatra, one of our sector Top
  Picks. Prominent growth from its banking and capital market businesses
  compel us to keep our BUY call due to its above-average growth with
  controllable asset quality.
- Year-end catalyst. The 38<sup>th</sup> Thailand International Motor Expo 2021 was from 30 Nov to 12 Dec 2021. New car sales during the event marked a 6.4% YoY decline to 31,583 cars. Besides the impact of COVID-19, we think this is because potential customers are awaiting the expected electric vehicle (EV) supportive measures by this year or early 2022 which could come in one of the following forms: excise and/or import tax reduction, lump-sum subsidy, or tax-refund subsidy. Still, we find that Toyota remains at the top spot (+5.0% YoY) for three consecutive years, followed by Honda (-8.7% YoY), Isuzu (+8.2% YoY), Mazda (-20.6% YoY), and MG (-1.4% YoY) (Figure 1). Note that Toyota and Isuzu remain at favorable spots as they have strong exposure to pickup trucks amidst an uptrend business cycle for logistic firms in Thailand.
- Our view. Apart from the positive sentiment towards related banking stocks, this event should spur new HP bookings to banks in 4Q21, particularly KKP, followed by Tisco Financial Group (TISCO, BUY, TP: THB111.50), and TMBThanachart Bank (TTB, NEUTRAL, TP: THB1.22).
- KKP will likely benefit the most in this area as it has a strong relationship with Toyota, Honda, Isuzu, and MG for its new HP cars, while such brands booked softer-than-peer decrease (Honda and MG) and higher car sales (Toyota and Isuzu). Its new HP lending was THB56.9m, making up 19.5% of its loans as of 3Q21 with a continued rise in penetration rate for new HP cars of 5.5% (2020: 4.2%).
- Other banks, which have significant HP lending in their loans, include:
  - i. **TISCO.** Although 49% of its loan or THB99.5m represents new HP loans, Ford (-16% YoY) and Mazda (-21% YoY), which accounted c.50% of its HP brands in 3Q21, booked a sharp drop in car sales for this event. However, we believe it will not see more new HP bookings despite the positive sentiment. Its penetration rate for new HP fell to 4.6% (2020: 5.2%).
  - ii. TTB does not disclose its car brand partners to us. HP loans account for THB272m or 20% of its loan. We see it gain new HP loan bookings from several car brands.
- **Key risks:** Virus mutations, containment measures, and the deterioration in asset quality.



KKP places emphasis on environmental issues, especially the air pollution problem, by granting green finance and supporting alternative fuel vehicles eg electric vehicles.

KKP treats employees fairly, respecting their human rights by focusing on employee development and care. It expects to achieve the vision of "A Great Place to Work" through its programmes and activities, creating positive employee and candidate experiences. It also does projects to support people's education, financial discipline, ethics and social defense, and relief and charitable contribution.

#### **G: EXCELLENT**

KKP has a corporate governance score of 5 out of 5 from the Thai Institute of Directors. The board of directors reviews and updates the bank's corporate governance policy regularly. This helps raise its standards to be comparable to international criteria. KKP has joined a network against fraud and corruption with the government organisation. It also provides channels for reporting any kind of internal misconduct activities.

KKP merged with Phatra Financial Group in Sept 2012 under a share-swap deal.

#### Valuation incorporating ESG overlay

Our intrinsic value is THB67.19, with key assumptions including:

- COE of 11.49%;
- ii. ROE of 12.00%;
- FY22F BVPS of THB63.78; iii.
- iv. Long-term growth rate of 2.00%

We also maintain a 2% discount for ESG, based on RHB's proprietary methodology. As a result, our TP is THB66.00, which implies a P/BV of 1.05x, near its historical mean.


