LPN Development (LPN TB)

Hindmost Among The Large Players; Keep SELL

- Keep SELL and THB3.00 TP, 30% downside and >8% yield. LPN Development, our Top SELL, will take time to surpass its low earnings level at least the next three years. This is as the industry challenges ahead will be tough for condominium developers as a whole, in our view.
- **3Q20** gross presales slowed vs **2Q20's** numbers. LPN posted 3Q20 gross presales of c.THB2.4bn, 68% of which came from condominiums. Although the gross presales numbers grew strongly (+58% YoY), we regard this as unimpressive. This was on the abnormal 3Q19 low base and a sacrifice between aggressive promotional campaigns (largely adopted to liquidate finished condominium inventory) and GPM delivered by these presales with price discounts. 3Q20 gross presales declined 24% QoQ, as both the condominiums segment and low-rise projects showed slower numbers: -16% and -37% QoQ.
- **3Q20 to be the lowest quarter.** After the weak 2Q20, we expect LPN's 3Q20 earnings to weaken further, with our earnings forecast at THB99m (-14% YoY, -36% QoQ). This decline should be attributed to our lower sales revenue forecast of THB1.1bn (+0.5% YoY, -11% QoQ) due to zero newly completed condominium projects beginning their transfers and project sales GPMs being lowered to 28.5% from 33.4% and 30.3% in 3Q19 and 2Q20 dampened by the pricing competition in the market.
- 4Q20: This year's highest quarter. As LPN has already started to transfer three condominium projects in October, we expect one of these three namely Lumpini Ville Phattanakan-Srinakarin, which has a current presale progress of 63% of the total project value to be the major development for revenue recognition in 4Q20. Coupled with LPN's attempts to liquidate condominium inventory throughout 2020, quarterly earnings should be the highest for this year. However, FY20 earnings are likely to be lower YoY, as core revenue and GPMs have been pressured by the unfavourable sentiment in the condominium market. Additionally, condominium inventory sliding down to the THB11bn level from THB13-14bn previously should only be a short-term positive, as the company has launched just one new medium-sized condominium project on a YTD basis. We expect LPN to see an immediate increase when it aggressively launches new condominium projects going forward.
- Limited upside from any changes in government policies. We think any significant changes in government policy that favours the residential projects market will be unlikely under the current circumstances. In case there are any new surprise measures unveiled, we believe LPN will benefit the least among the industry players. This is as the bulk of its projects portfolio is skewed towards the low- to mid-end market, which has already been supported by a special low rate for transfer and mortgage fees valid till 24 Dec under the low-ebb interest rate environment.


