Muangthai Capital (MTC TB)

Key Microfinance Player Emphasis; Keep BUY

- Still BUY and THB73.00 TP, 21% upside. Post ground checks, we see Muangthai Capital as superior to peers in terms of place and products, while price and promotions are competitive. Its growth momentum remains on the new branch expansion and cost management path. Downside: Cutting industry loan rates further will limit growth. Its current share price, near -1.5SD from the forward P/BV, has already absorbed this to some degree.
- We conducted ground checks on three key Thai microfinance players MTC, Srisawad (SAWAD TB, NR), and Ngern Tid Lor (TIDLOR TB, NR) (Figure1) – posing as a loan applicant. We compared their 4Ps marketing (products, place, price & promotion) and tried to find some colour on overall sector loans demand in 2Q21.
- Product. All players offered a wide range of loan types, with vehicle and land title loans the most popular. This is followed by personal, nano, and hire purchase loans. MTC is outstanding in motorcycle title loans – the industry's highest market share – vs SAWAD, which has the highest portion and market share in land title loans. TIDLOR has exposure and gained the most share in auto title loans. As most households here own at least one motorcycle, title loans for the latter play a key role in the sector's portfolios.
- Price & promotion. SAWAD is now running a limited promotion (12 May-30 Jun) on interest rate charges for motorcycle and auto title loans (Figure2): c.11% from c.15%, lowest among its peers. This follows the move by the SAWAD and Government Savings Bank JV to lower industrial loan rates. MTC: c.15% and c.18% for motorcycle and auto title loans. TIDLOR: c.23% and c.21% for motorcycle and auto title loans – the highest. We expect the price competition headroom to be the limiter, as the risk-reward may not attract players to cut rates further. Additionally, price is not the only thing clients care about, as services and convenience are factors too.
- **Place.** We believe MTC is superior in this. In the area we scoped, an MTC branch was easier to find: It had two branches vs one each for SAWAD and TIDLOR. Note: MTC, SAWAD, and TIDLOR have 5,005, 4,797, and 1,076 branches as of 1Q21. All players' locations and branch sizes were similar to each other, with 1-2 commercial buildings (Figure 1) and 1-3 staff/branch. The locations are usually near community zones and are eye-catching.
- 2Q21 outlook. After talking with MTC, SAWAD, and TIDLOR staff, we found that QTD loan demand was not likely to be stronger QoQ as earlier anticipated, given the longer-than-expected pandemic and higher-than-expected new case numbers. Hence, we only expect earnings to grow only slightly QoQ despite the boost from lower interest rate charges, start of the cultivation season, and reopening of schools in 2Q21.
- **2H21 outlook.** We expect stronger 2H21 earnings vs 1H21, given its new branch expansion and opex management. We believe vaccine distribution and the economy's reopening are the key catalysts to drive client confidence for loans demand and contain credit costs in 2H21.







Figure 6: MTC's 12-month forward P/E
