เมืองไทย แคปปิตอล (MTC TB)

ถอยออกมารอดูก่อน; downgrade คำแนะนำเป็น "ถือ"

- downgrade คำแนะนำเป็น "ถือ" จากเดิม "ชื้อ" และลดราคาเป้าหมายลงเป็น 64.00 บาท จาก เดิม 69.00 บาท upside 5% เรามีมุมองบวกน้อยลงต่อแนวโน้มการเติบโตของ MTC โดยการเติบโต ของ MTC อาจชะลอลงเร็วกว่าคาด จากการแข่งขันที่สูงขึ้นและเกณฑ์ข้อบังคับที่เข้มงวดขึ้น ประเด็น เหล่านี้อาจทำให้นักลงทุนปรับมุมมองต่อหุ้นนี้ลงมาเป็น wait-and-see ราคาเป้าหมายใหม่ของเรา ประเมินโดยใช้วิธี GGM ที่ 4.5 เท่า ซึ่งใกล้เคียงระดับ -2SD จาก P/BV เฉลี่ยระยะ 5 ปี เรามองว่า เหมาะสมแล้ว ปัจจัยหนุนในระยะสั้นของ MTC มีเพียงความต้องการสินเชื่อที่ดีขึ้นใน 4Q64
- สรุปประเด็นสำคัญ ผู้บริหารคาดว่าสินเชื่อในปี FY65 จะโตได้ 30% YoY จากสินเชื่อจำนำทะเบียน เป็นสำคัญ จำนวนสาขาเปิดใหม่ของ MTC เพิ่มสูงเป็นประวัติการณ์ในระหว่าง 3Q64 โดยตั้งเป้าที่จะยึด พื้นที่ที่โดดเด่นต่าง ๆก่อนคู่แข่ง MTC วางแผนจะลดผลกระทบอัตราผลตอบแทนจากสินเชื่อที่ลดลง ต่อเนื่องตั้งแต่ 1Q61 โดยการเพิ่มสินเชื่อดอกเบี้ยสูง (สินเชื่อเช่าซื้อและสินเชื่อส่วนบุคคล) และเชื่อว่า อัตราผลตอบแทนที่ไน้มต่ำจะเริ่มลดลงในอัตราที่ชะลอตัวใน 4Q64 และทรงดัวได้ตั้งแต่ 1Q65
- เปิดตัวธุรกิจใหม่ตันปี FY65 MTC วางแผน ที่จะเริ่มธุรกิจ ซื้อก่อนจ่ายทีหลัง (BNPL) ผ่านบริษัทลูก MTPL แต่ในปัจจุบันยังไม่เปิดเผยรายละเอียดกลยุทธ์ด้านหุ้นส่วน อัตราดอกเบี้ย หรือค่าธรรมเนียม อย่างไรก็ตาม ผู้บริหารคาดว่าจะเติบโตในสินเชื่อขนาดเล็กกับฐานลูกค้าเดิม โดยตั้งเป้าจะเพิ่มขนาด portfolio ให้เทียบเท่ากับสินเชื่อเช่าซื้อ (4% ของสินเชื่อทั้งหมดใน 3Q64) BNPL เราคาดว่าต้องใช้เวลา อีกหลายปีก่อนกว่าจะเห็นผลและสร้างกำไรที่มีนัยสำคัญต่อ MTC เราจึงยังไม่รวมผลในส่วนนี้เข้าใน การคำนวณ
- ปัจจัยฉุดรั้ง MTC i) ดอกเบี้ยสินเชื่อจักรยานยนต์ที่ลดลง (ตั้งแต่ ธ.ค. 2563) ii) การปรับลด ค่าธรรมเนียมการทวงถามหนี้ (ตั้งแต่ ก.ย. 2564) iii) การแข่งขันที่สูงขึ้น iv) ประชาพิจารณ์ปรับลด ดอกเบี้ยเช่าซื้อ และ iv) อัตราดอกเบี้ยขาขึ้น
- ต่ำกว่าประมาณการ กำไรสุทธิของ MTC ในไตรมาส 3Q64 อยู่ที่ 1,201 ลบ. (-6% QoQ, -10% YoY) ซึ่งต่ำกว่าที่เราและตลาดดาด ตามรายได้ที่เพิ่มขึ้นน้อยกว่าคาด กำไรลดลงเทียบ YoY เป็นครั้งแรก ขณะที่กำไรสุทธิของ 9M64 อยู่ที่ 3,864 ลบ. (+0% YoY) คิดเป็น 71% ของประมาณการกำไรปี FY64 ของเรา รายได้เพิ่มขึ้นเพียง 2% QoQ โดย NII เพิ่มขึ้น 4% แม้รายได้ค่าธรรมเนียมจะลดลง 10% จาก มาตรการรัฐเกี่ยวกับค่าธรรมเนียมการทวงถามหนี้ในเดือน ก.ย. เป็นต้นมา สินเชื่อ (+6% QoQ, +26% YoY) เดิบโตจากการเพิ่มจำนวนสาขาอย่างรวดเร็ว (สาขาใหม่ 381 แห่ง QoQ) NIM ยังคงลดลงต่ออยู่ ที่ 15.9% (2Q64: 16.6%) เป็นผลต่อเนื่องจากการลดดอกเบี้ยสินเชื่อจักรยานยนต์ opex เพิ่มขึ้น 8% QoQ ส่งผลให้ PPOP ลดลง 2% และ CIR เพิ่มขึ้นเป็น 51.2% ด้วยเศรษฐกิจที่ไม่แน่นอน ECL จึง เพิ่มขึ้น 39% QoQ ส่งผลให้ credit cost เพิ่มขึ้นไปที่ 93bps (เทียบ 72bps ใน 2Q64 และ guidance ที่ 80-100bps)
- กลับมาฟื้นตัว QoQ ใน 4Q64 เราคาดว่าความต้องการสินเชื่อจะยังเพิ่มต่อ ขณะที่อัตราผลตอบแทน สินเชื่อจะชะลอการลดลง อย่างไรก็ดี หากเทียบ 4Q63 แล้ว กำไรสุทธิอาจลดลง YoY จากค่าใช้จ่าย SG&A ที่เพิ่มขึ้นและรายได้ค่าธรรมเนียมที่ลดลง
- เราลดประมาณการกำไร FY64-66F ลง 5-8% ให้สอดคล้องกับสมมติฐานการเติบโตของ MTC ที่ ชะลอลง และลดราคาเป้าหมายของเราลงไปที่ 64.00 บาท



4Q21 outlook

We expect loan demand to continue from:

- i. The impact of its aggressive branch expansion from 3Q21;






Figure 5: MTC's 12-month forward P/BV

- ii. A rise in the agricultural income index, both in prices and production (Figure 5);
- iii. Better consumer confidence;
- iv. A pick-up in repair and home improvements after the floods.

Also, a mild uptick in motorcycle title loan rates to 16-18% from 15-18% since mid-August will help temper the downtrend in loan yields. Against 4Q20, however, net profit would fall YoY on higher SG&A, and lower fee income.

Revisions to earnings estimates

We cut FY21-34F net profit by 5.3%, 7.8% and 7.9% to reflect:

- i. Lower average loan yields of motorcycle title loans to 16% (from 16.5%) and HP loans to 22% (from 24%);
- ii. Higher average cost of funds of 3.48%, 3.57% and 3.57% for FY21-23 (from 3.38%, 3.48% and 3.48%);
- iii. Lower debt collection fee following new Government Gazette on debt collection fees (from Sep 2021);

Valuation

Our GGM-derived intrinsic value drops to THB62.45 from THB67.91 on the following revisions in assumptions:

- i. Cost of equity of 10.42%;
- ii. Lower ROE of 22%, from 23%;
- iii. BVPS declines to THB14.25 from THB14.60;

The GGM-derived P/BV of 4.38x is near -2SD from its 5-year historical mean.

We believe MTC should trade near -2SD from its historical mean to reflect stricter regulations and expectations of competition being more intense moving forward, in view of its stronger competitors and new players in the industry.

That said, with a 2% premium for ESG based on RHB's proprietary methodology, our TP drops to THB64.00 from THB69.00.



Figure 6: Agricultural income index has shown strong numbers in 2021, given the economic recovery and supply shortage


