

- Maintain BUY with THB49.00 TP, 37% upside and 2% yield. Osotspa's 3Q20F earnings look resilient with core profit expected to grow 10% YoY and 12% QoQ, thanks to strong sales and operating margins from its vitamin C drink products. 4Q20F growth should strengthen, driven by new production capacity in Thailand and Myanmar, and continued benefits from its efficient cost controls.
 C-Vitt production hike strengthens domestic sales. Osotspa's domestic sales are likely to rebound post COVID-19. We expect a V-shape recovery
- C-Vitt production like strengthens domestic sales. Osotspa's domestic sales are likely to rebound post COVID-19. We expect a V-shape recovery for its functional drinks on pent-up demand, benefitting from the market leadership of its C-Vitt vitamin C drinks, along with the full-quarter operation of its new machines for the product. The energy drinks market remains soft, but Osotspa still retains its leading market share. We expect a U-shape recovery for its energy drinks products, with sales contraction improving to lower negative single digits by end-3Q20. Only some of Osotspa's personal care products such as fragrances are affected by consumers' cautious spending.
- 3Q20F earnings to grow 10% YoY. We forecast 3Q20 core profit of THB902m (+10% YoY, +12% QoQ), driven by improving domestic sales and continued effective corporate cost control programme. Sales are expected to grow 7% YoY and 15% QoQ, while the ongoing COVID-19 spread in Myanmar may affect Osotspa's topline by <8% this quarter. Our GPM assumption of 34.3% is slightly below that of the same period last year due to higher revenue share from low-margin C-Vitt product distribution, but the impact may be limited by ongoing efficient corporate cost control under the "Fit-Fast-Firm" programme and continued lower sugar tax rate which should help support its energy drink side. Growth supports include our expected higher equity profit of THB84m (+17% YoY) from C-Vitt manufacturing, and opex-to-sales ratio assumption of 21.5% (-1.6ppt YoY). Operating expenses, including marketing activities, may rise post COVID-19, but sales growth will likely strengthen.
- 4Q20F likely a stronger quarter. We are also optimistic on Osotspa's 4Q20F outlook, based on the inauguration of its new beverage filling facility in Myanmar in July which may materially improve its overseas business costs from 4Q onwards. We also expect a continued expansion of its traditional trade store coverage for C-Vitt products from its current one-third of the targeted distribution through its traditional trade store network. Both factors would be key earnings supports for the final quarter this year and help FY20F earnings to grow 15%.
- Stay BUY. Its attractive forecast ROE of 20%-22% for 2020-2022 is backed by expected strong 3-year earnings with a 14% CAGR, driven by its product leadership, production capacity hikes and margin expansion from continued improvements in operating efficiency. We keep a prospective 39x FY20F P/E to drive the THB49.00 TP. The DCF methodology derives THB42.00 as a solid support level to represent the stock's lower range FY20F valuation.

การเปิดเผยการประเมินดัชนีชี้วัดความคืบหน้าการป้องกันการมีส่วนเกี่ยวข้องกับการทุจริตคอร์รัปชัน (Anti-Corruption Progress Indicators) ของบริษัทจดทะเบียนในตลาดหลักทรัพย์แห่งประเทศไทยที่ จัดทำโดยสถาบันที่เกี่ยวข้องซึ่งมีการเปิดเผยโดยสำนักงานคณะกรรมการกำกับหลักทรัพย์และตลาดหลักทรัพย์นี้เป็นการดำเนินการตามนโยบายและตามแผนพัฒนาความยั่งยืนสำหรับบริษัทจดทะเบียนโดย ผลการประเมินดังกล่าว สถาบันที่เกี่ยวข้องอาศัยข้อมูลที่ได้รับจากบริษัทจดทะเบียนตามที่บริษัทจดทะเบียนได้ระบุในแบบแสดงข้อมูลเพื่อการประเมิน Anti-Corruption ซึ่งอ้างอิงข้อมูลมาจากแบบแสดง รายงานข้อมูลประจำปี แบบ (56-1) รายงานประจำปีแบบ (56-2) หรือในเอกสารหรือรายงานอื่นที่เกี่ยวข้องซึ่งเป็นบุคคลภายนอก โดยมิได้เป็นการประเมินการปฏิบัติของบริษัทจดทะเบียนในตลาดหลักทรัพย์ แห่งประเทศไทยและมิได้ใช้ข้อมูลภายในเพื่อการประเมิน เนื่องจากผลการประเมินดังกล่าวเป็นเพียงผลการประเมิน ณ วันที่ ปรากฏในผลการประเมินเท่านั้น ดังนั้นผลการประเมินจึงอาจเปลี่ยนแปลงได้ ภายหลังวันดังกล่าว หรือรับรองความถูกต้องครบถ้วนของผลประเมินดังกล่าวแต่อย่างใด
