Another year of a drop in earnings. FY19 net profit came in at THB5.36bn (-11% YoY) due to sale revenue of THB39.9bn falling 10% YoY in tandem with its full-year presales weakening 30% YoY, as well as increasing financial cost after its interest-bearing debt rose 15% YoY to THB31.1bn as at FY19. 4Q19 earnings was THB1.8bn (-9% YoY, +99% QoQ).

Dim Outlook For a New Growth Cycle; Still SELL


- Business target on "best-effort" basis. Pruksa has guided to give its best effort to maintain FY20 performance at the same level as FY19. Based on its business plan, management has set revenue target at THB40bn, implying zero growth, while its presales target has been set higher at THB38bn (+7% YoY) under a more conservative plan to launch new projects worth THB36bn (-13% YoY).
- . Pruksa's five strategies for FY20 include solidifying its existing base of core business and focusing on expanding new projects into the high-end market; increasing the role of digital marketing and utilising customer information via data analytics solution; prioritising the sale of completed condominium units; sustaining recurring income especially from the sale of products from its precast factories; and optimising its product specification for better cost control.

Based on the above, we believe that its 7% YoY presales growth target will be difficult to achieve due to intense competition within the industry as Pruksa does not have any distinguishing factor to place it at an advantage. Therefore, our best-case scenario is that FY20F presale value should flatten YoY at THB35bn as the company has set a conservative plan to launch new projects this year, mainly in 2H20. However, we believe the company should instead focus on the sale of its completed units - a strategy that has been adopted by many other large developers.

• Earnings prospects at a low ebb. We revise down our earnings prospects for FY20F-21F by 2-4% due to our concerns over its low orderbook of only THB11bn being recognised in FY20 (Figure 2). This implies the company's efforts to liquidate its housing inventory going forward. FY20F-22F earnings should range between THB4bn and THB5bn.
