Maintain NEUTRAL, TP of THB37.30, 5% upside with c.3% FY20F dividend yield. PTT has announced that it will cut spending by 22% this year, to THB53.9bn, and projects affected by this will be deferred to 2021-2022. Projects that are in development will move forward as planned. The revision has a minimal impact on our valuation. This year will be challenging for PTT, as earnings will be depressed due the collapse in crude oil price



• Outlook for 9M20. Our view has not changed. We expect 2Q20F recurring net profit to soften to THB13bn, and anticipate a recovery in 2H20, at c.THB20bn per quarter. This is with the assumption that the crude oil price will slowly recover to USD28.00, USD37.00 and USD45.00 per barrel in 2Q20, 3Q20 and 4Q20. We expect demand - both domestic and global to recover as the world eases out of lockdowns. We believe that OPEC+ production restraints, and production curtailment from higher-cost producers, will result in a global inventory drawdown - which should engender a recovery in commodity prices.




Figure 1: Revisions to PTT's 5-year investment plan
