# PTT Global Chemical (PTTGC TB)

## Strong GRM, Opportunity To Accumulate; BUY

- BUY, new THB76.00 TP from THB73.00, 30% upside, c.6% yield. PTT
  Global Chemical should benefit from higher gross refinery margins (GRM)
  in 4Q21 and FY22, in tandem with stronger oil demand from the economic
  recovery. PTTGC is looking to increase its exposure to high-value products,
  while Omicron fears appear to be easing, given the less severe symptoms
  seen among those infected.
- Solid GRM; soft petrochemical business in 4Q21. PTTGC is expected to see weak petrochemical spreads in 4Q21 due to new supply coming in (paraxylene spread over condensate spread last week remained at USD253.00/ton, -17% from USD304.00/ton in 3Q21). However, PTTGC should benefit from the refinery business in 4Q21, which will help reduce the impact of its soft petrochemical business. The benchmark Singapore GRM has increased, and is moving in a USD5.00-6.00/bbl range in 4Q21, up from USD1.00-2.00/bbl in 3Q21 back to pre-COVID-19 levels. Hence, PTTGC's market GRM is expected to move in a USD3.50-3.90/bbl range from USD3.20/bbl in 3Q21, due to higher demand from middle distillate products like gasoline and diesel oil. Rising demand from the transportation sector and for heating oil from the northern hemisphere's winter season should increase gasoline and diesel demand.
- Long-term developments are underway. The Allnex deal is expected to be completed in late 4Q21 or 1Q22, while Vinythai Plc (VNT TB, NOT RATED) is undergoing the tender offer process, with the results expected in 4Q21/1Q22. PTTGC plans to boost its revenue from high value-added products, from 30% of its revenue in 2021 to 49% in 2026.
- Valuation remains cheap. Stock prices have been under pressure, owing to news about the COVID-19 Omicron variant. The impact on PTTGC's share price, however, has been largely shielded by the company's strong long-term fundamentals. PTTGC is one of the most efficient refiners and petrochemical players in the Asia-Pacific region, and we believe it will continue to be a strong player post COVID-19. Its share price is also cheap, when compared with other energy stocks, which trade at equal or higher than book value. PTTGC has recently been trading at below its book value (0.8x FY22 P/BV), which is also below its 5-year mean of 1.0x.
- Imputing ESG into valuations. PTTGC has become a successful player in terms of applying ESG principles and developing sustainable operations. Based on our in-house proprietary methodology, we derive an ESG score of 3.4 out of 4.0. Accordingly, we apply a 4% premium to our derived intrinsic value THB73.00 with a target P/BV of 1.0x, in line with its 5-year mean to arrive at our new THB76.00 TP. Key downside risks: Prolonged pandemic, higher-than-expected supply of petrochemical capacities.



For Thai refineries/petrochemicals, we use P/BV as a valuation basis. This is due to high volatility in the earnings as a result of stock gains/losses. We believe that DCF valuation is not appropriate as share price and earnings are highly seasonal.






Figure 1: Singapore GRM moves back to pre-COVID-19 levels


