Industry Outlook Uptick; Upgrade To NEUTRAL

- Upgrade to NEUTRAL from Underweight, as there should be ongoing
 positive momentum in the low-rise projects segment, which was initially
 driven by opportunities arising from COVID-19's impact. This was also
 despite the overall industry's slow progress in liquidating condominium
 supply. Although this positive trend cannot guarantee brighter earnings
 prospects for all developers next year, we believe our selective large
 developers will inevitably benefit from this trend. Our Top Picks: Supalai
 and Land and Houses (LH).
- Most 3Q20 earnings were in line. All large developers, except LH, showed 3Q20 earnings that were in line with our estimates. However, after excluding extra items from provision reversals, LH's 3Q20 core profit remained in line with our forecasts. Only AP (Thailand) (AP) showed 3Q20 earnings results that were stronger YoY and QoQ. The determining factor behind the overall performances during this period was the revenue growth from low-rise projects each developer can command. GPMs during 3Q20 improved QoQ on lower pricing competition within the industry after the fierce competition seen in 2Q20 during the panic that erupted over the pandemic. The YoY declines from 3Q19's GPM average, however, was on most developers' lower topline contributions from condominiums.
- Another attempt in 4Q20. Among the large developers, only AP can guarantee its FY20 net profit growth target, as its 9M20 earnings results have almost matched its overall FY19 bottomline this was despite 4Q20 net prospects looking QoQ lower. For other large developers, 4Q20 should be the last chance to boost earnings growth to minimise YoY declines in full-year net profits. While we believe they are unlikely to hit their FY20 earnings growth targets, we think these developers AP excepted will be able to mark their highest quarters in 4Q20. This is especially so for Supalai, which we expect to see solid YoY and QoQ earnings growth. This is because it is starting the transfer of the high-GPM Supalai Oriental Sukhumvit 39 condominium project during this period.
- Earnings upside in FY21. Even in FY21, we expect the low-rise projects segment to continue its significant role in determining the industry winners. Therefore, developers with solid brands in the single-detached home (SDH) and townhouse markets should maintain a competitive edge almost throughout the whole of next year. Based on the slow momentum in the condominium segment, we expect all large developers to launch only new condominium projects in selective locations for FY21 something that most have already done so on a YTD basis. Under this anticipated scenario, low-rise project projects will remain the major factor in determining FY21's earnings outlook, in our view. Hence, we expect Supalai and LH to be the most trustworthy in this respect. In addition, there should be earnings upsides to their FY21 net profits too, as both are planning to spin off their recurring-income assets into REITs.
- Upgrade to NEUTRAL, as we expect the low-rise projects segment to continue doing well in FY21. Most of the large developers have shown solid performances in this battleground too. However, the overall industry remains under pressure, given the high loan rejection rates within the lowend market and ongoing condominium inventory sell-offs.



Only AP showed both 3Q20 YoY and QoQ earnings growth; others – except LPN Development – improved QoQ earnings only





Figure 2: Large developers with strong brands in SDH and townhouse markets - except Pruksa - enjoyed low-rise project presales in 9M20










