Still TAKE PROFIT with new THB 17.50 TP from THB 19.20, 2% upside. While 2Q20 earnings are expected to bottom out on commercial properties' gradual lockdown relaxation, we remain cautious on Siam Global House's full-year outlook. GLOBAL may be dragged by weakening private consumption and softening margin prospects. Our key concerns: High inventory levels and tightened balance sheet from store expansions.

Siam Global House (GLOBAL TB)

Softening Outlook; Still TAKE PROFIT


- While store closures and the nationwide lockdown should dampen its revenue outlook in the upcoming quarter, weakened private consumption, and property and construction sector slowdowns should be the key negative factors that pressure GLOBAL's full-year outlook. Its store locations largely in Thailand's provincial areas - should see higher impact vis-à-vis its peers. This was not helped by the sluggish purchasing power in rural areas due to the drought and low commodity prices this year. GLOBAL's previous plan to improve margins via house brand products should also struggle on a rising competitive pricing environment and flood of online promotions in the near term. We see FY20F GPM softening slightly to 21% vs 22.2% before posting a c.21.3% recovery in 2021-2022.
- The change in lease recognition from Thai Financial Reporting Standards 16's adoption has had a minimal impact to GLOBAL's bottomline. This was due to its store expansion model, which focuses on owning properties rather than leasing. We also think its plans to open franchise/standalone stores for La Mayon and USUPSO should not create substantial impact to its balance sheet or bottomline anytime soon.
- Despite the unprecedented economic conditions, management reaffirmed that its domestic expansion plan to reach 100 stores by 2023 (+10% pa) remains intact. While we are positive on GLOBAL's plan to lower the sizes of new stores - which should help the company gear down the additional future capex/staff costs - we think its pre-opening stores will take longer time to gain sales momentum. We also remain cautious on USUPSO's expansion - we believe this brand may not create significant impact to GLOBAL's near-term earnings.
- Key concerns: Inventory and balance sheet. We remain concerned over the company's ability to manage working capital, given its high inventory levels with slowest turnover vis-à-vis its peers (Figure 1). The inventory pileup and aggressive expansion should continue to constrict its balance sheet, preventing GLOBAL from sustaining its expansion rate while exposing it to downside risks on fair value adjustments to its outdated inventory.
- We retain our call, while revising FY20F-21F revenue down by c.8% to incorporate the national lockdown and weakened outlook. Our earnings for this period were cut 13% on the softening margin prospects. Although the share price's sharp rebound resulted in the valuation starting to stretch (+1SD), the current valuation level is also relatively high vs peers. Our TP implies 33.7x FY20F P/E – in line with the historical average.
