

- Earnings revision. GPM has shown a downtrend since 2Q19 following the completion of all its high-GPM power plant construction works. The company is seeking new high-GPM projects to bump up the overall margin performance in the future. In addition, the revision of key assumptions the two companies' operating the Pink-Line and Yellow-Line MRTs will result in Sino-Thai's profit sharing from associates for the year to be lower YoY we expect it at THB50m. Therefore, we cut FY20F-21F earnings by 14%.
- Signing new contracts soon. In spite of lower earnings prospects, there is a good news in the form of a new large project to improve its overall GPM from current historical lows. On 19 Jun, BBS consortium - Sino-Thai has a 20% stake - is set to sign a concession contract to develop and operate the U-Tapao International Airport expansion after winning the bid for the 50-year concession earlier this year. After signing the concession, Sino-Thai, being the construction arm of the consortium, should secure a construction contract worth THB20-22bn for Phase 1 - the contract is expected to be awarded this year. We expect the company to start recognising this project's construction revenue from 4Q21F.
- TP lower to THB17.50. After the earnings downgrade, our new TP of THB17.50 implies 22.7x P/E, which is +1SD from its 10-year historical P/E excluding FY17 marking an earnings loss. We believe the valuation is justified by Sino-Thai's brighter prospects of securing new orders in the near-term.
