Fixed Cost-Push Margins Compression

- Still NEUTRAL. While the potential of a second lockdown might again lead to a rise in data consumption and remote activities, we stay cautious on topline outlook, which should continue to be pressured by weakened spending and sluggish recovery in tourism-related sectors. While FY21's industry horizon should continue to be challenged by fixed cost-push margins compression, cash flow concerns should ease, in our view.
- While sluggish data monetisation, rise in price sensitivity, and on/off discount pricing campaigns should continue to pressure industry topline, we think Advance Info Service (AIS) and True Corp have the competitive edge in terms of convergence services. They remain in a better spot to stabilise ARPUs due to their bundled packages with value-proposition approaches. While a potential second lockdown should re-elevate data consumption and data yields this year remain at record low levels the massive acquisition of spectrum bandwidths that enhance sector-wide network capacities should help operators sustain ARPU levels by offering higher data packages within the same price range without constraints. We remain cautious over short-term 5G-services demand, as we think it will continue to be a value adder only (ie free trials usage and marketing gimmicks) rather than a growth driver, given the softening purchasing power prospects.
- Margins squeezed but cash flow eases. While the rise in fixed asset costs

 which came in the midst of flattish sector revenues should remain the key threat to industry margins, the: i) Gearing down of cash capex cycles from the previous 4G network expansions, ii) longer vendor financing, and iii) lower instalments from spectrum licenses should start to ease up operators' 2021 cash outflows. We also expect them to step up cost optimisation programmes (eg headcount controls and network optimisation) with more prudent controls on network investments to bolster bottomlines.
- Despite the long drawn-out pricing competition between core players, we still expect the industry's fixed broadband (FBB) revenue to continue growing c.6-8% in FY21-22 (9M20: +6% YoY), largely driven by the rise in data consumption, internet-based activities, and household penetration in rural areas. We retain our view that AIS should remain the top performer in this segment, supported by its well-heeled convergence services with relatively low convergence subs base proportion vs existing mobile subs vis-a-vis its peers.
- While the merger of TOT and CAT Telecom (slated for 1Q21) could create the third-largest telco firm in terms of asset size and bandwidth on hand, we think the newly formed National Telecom (NT) will not create a significant impact to the industry's competitive landscape in the short term. This is no thanks to NT's clients base, which is relatively small vis-à-vis the private operators, as well as the sloppy change of its organisational structure.
- While the potential economic measures urged by the National Broadcasting & Telecommunications Commission (NBTC) to support the upcoming lockdown have yet to be finalised, we remain optimistic that sector earnings downsides will be limited. This is because the Government is expected to provide similar compensations vis-à-vis the first lockdown.
- Key downside risks are mostly regulatory, ie the NBTC's board transition, and changes in the Telecommunications Business Act and related regulations imposed by the Government. Upside risks: A tourism recovery post COVID-19 vaccination that revives purchasing power and relatively laggard sector valuations. Still Top Pick: AIS, as it remains well balanced between a solid core operations outlook and tangible growth areas.













Figure 3: Mobile prepaid ARPU (THB/month)


Figure 4: Mobile postpaid ARPU (THB/month)




Figure 7: Mobile service revenue (THBm)







Figure 9: Network opex (THBm)

Figure 10: Depreciation & amortisation (THBm)








Figure 11: Total assets (THBm)
