

13 May 2020 **Thai Oil** (TOP TB)

On Track For a Recovery

- Maintain BUY and THB54.00 TP, 23% upside and 3% yield. At an analyst meeting today, Thai Oil highlighted the impact of COVID-19 on its operations and action plans moving forward for this challenging year. The company expects GRM to recover as a result of a lower official selling price (OSP) crude discount in 2Q20, while 2H20 should see oil demand recover. TOP's refinery expansion project remains on track for commercial operation date (COD) in 1Q23.
- The impact of COVID-19 on TOP: A large stock loss as a result of the oil price collapse. However, this has reset the crude oil price at a lower level with an OSP discount. For the March-April period, demand for jet, gasoline, and diesel fuels fell 89%, 10%, and 23% YoY.
- Optimise and rationalise. TOP will be looking to optimise production and sales, with the objective of lowering jet fuel while increasing diesel fuel and aromatics production, and optimising base oil and bitumen yields. The company has lowered its 2020F capex 20% from its original plan to USD1.7bn. It also increased 2021-2022 capex to USD1.4bn (+34%) and USD522m (+11%). TOP has ample cash on hand, ensuring adequate liquidity for the year, with sufficient credit facilities for the current expansion plans.
- Commodity outlook for 2020. According to the International Energy Agency, oil demand is expected to fall by 9.3mbpd. The production cuts are not sufficient to offset demand destruction, with production down by 5.9mbpd vs a demand decline of 9.3mbpd. However, 2H20 demand is expected to outstrip supply, as demand recovers while supply remains restrained by the producers. Global inventory continues to build as of 7 May, onshore inventory levels in America, Middle East/Africa/the EU, and Asia-Pacific stood at 89%, 81% and 92%.
- **TOP** has in place optimisation and the flexibility to capture rebounding market opportunities. This, together with the Middle East OSP crude discount and recovering demand, will help improve GRM, in our view.
- Clean Fuels Project (CFP) update. Construction at the site is still moving forward, with the construction labour force not an issue, although foreign workers did leave the project when COVID-19 began. TOP will prioritise equipment from abroad. The focus remains the same with this project, with COD by 1Q23 as scheduled. The company will re-prioritise, with any project not started to be shifted or delayed. CFP is a USD3.2bn investment, which should increase TOP's capacity to 400kbpd from 275kbpd currently.



For the Thai refineries/petrochemicals, we use P/BV as a valuation basis. This is due to the high volatility in earnings as a result of stock gains/losses. We believe the DCF valuation is not appropriate, as the share price and earnings are highly subject to seasonal factors.

TOP is a 275kbpd refinery with an aromatics and lube base business that adds value to its refinery. The three businesses make up nearly 90% of EBITDA, with the refinery accounting for 60-80% of consolidated EBITDA (depending on margins).
