• 2Q20 market GRM was at USD1.40/bbl as refined product spreads weakened due to softer demand. The company had to export its jet fuel at a USD5.00/bbl discount to the market price, impacting GRM by USD0.50/bbl. Market GIM from the aromatics business remained stable at USD1.60/bbl, while the lube base business contribution fell further to USD0.00/bbl as demand weakened. Accounting GIM totalled USD1.10/bbl, vs -USD10.10/bbl in 1Q20. The refinery, aromatics and base oil utilisation rates were 98%. 75% and 89%.

Outlook for 2H20. We initially expected the oil market to rebound after global lockdowns had ended. However, the resurgence of COVID-19 infections around the world led to rolling lockdown measures taking effect in cities across the globe. As such, demand remains fragile and refining spreads are still weak, albeit showing intermittent signs of improvement. Gasoline and diesel spreads are currently at USD4.45/bbl and USD4.19/bbl – at less than half their normal spreads. The jet spread is at a meagre

• We remain concerned with the weak refined product spreads, which point to a weak 3Q20F. At current spreads, its market GIM is at USD2.60/bbl. This indicates a possible operating net loss of THB500m, but stock gains for the quarter could help alleviate the dismal outlook. We remain cautiously optimistic that recovery is on the horizon – but this may be delayed until 4Q20F. We maintain our NEUTRAL recommendation on

-USD0.38/bbl, since global air travel remains limited.

Valuation basis

For the Thai refineries/petrochemicals, we use P/BV as a valuation basis. This is due to the high volatility in earnings as a result of stock gains/losses. We believe that the DCF valuation is not appropriate, as the share price and earnings are highly subject to seasonal factors.

Key drivers

- i. Crude oil prices as it is the main feedstock;
- ii. GRMs, which fluctuate depending on seasonal demand:
- iii. Stock gains/losses on crude oil price volatilities;
- iv. THB/USD rate where product and feedstock costs are valued in USD.

Key risks

- i. Crude oil prices;
- ii. THB/USD rate fluctuations;
- iii. Demand and supply for products

Company Profile

Thai Oil is a 275kbpd refinery with an aromatics and lube base business that adds value to its refinery. The three businesses make up nearly 90% of EBITDA, with the refinery accounting for 60-80% of consolidated EBITDA (depending on margins).

Figure 5: TOP's forward P/BV and SD levels




Figure 6: Thai Oil & Gas Index's forward P/BV and SD levels
