Look Forward To a Solid Quarter In 4Q21; BUY

- Maintain BUY and a SOP-based TP of THB3.80, 20% upside with FY21F 4% yield. After WHA Corp's management admitted to toning down its FY21 targets due to stringent pandemic-related restrictions in Vietnam, we expect it to mitigate this impact with a possible upside, via: i) Extra gains from injecting its warehouse assets into a REIT in December, and ii) a solid earnings base from its logistics warehouse business.
- Business targets revised. WHA's management has admitted that it has encountered challenges in selling industrial land during the COVID-19 pandemic. Yesterday, it announced that it has cut its FY21 industrial land sales target to 70 *rai* (11.2 ha) from 305 *rai* (49 ha), in Vietnam. The group also increased its industrial land sales target for Thailand to 750 *rai* (120 ha), from 725 *rai* (116 ha). This was due to the strict lockdown in Vietnam which delayed government approvals, and led to WHA selling only 33 rai (5.3 ha) of land in 1H21. That said, its new target for Thailand's industrial land sales in Thailand make up 32% of the new FY21 target. Currently, the top new clients of its industrial estates include auto players (especially those in the supply chain for Great Wall Motors), electronics companies and consumer product manufacturers.
- **Impact on transfer.** WHA has held back on setting targets for industrial land transfers. We also think the transfer value will also be affected by its decreased estimate on industrial land sales in Vietnam. Meanwhile, the transfer process in Thailand has been not easy, due to international border restrictions barring foreign investors from entering the country. Investors from China comprise the majority of its foreign clients.
- Strong interest in asset monetisation. This is a positive near-term driver for the company, as it aims to hive off its 180,000sqm warehouse to WHA Premium Growth REIT (WHART TB, NR). About 76% of space to be sold to the REIT is the warehouse project leased to Alibaba for logistics management, and is under a long-term lease of 15 years. This should boost interest among unitholders, and the group may be able to divest the asset at an attractive price of >THB30,000 per sqm. As this transaction is likely to be finalised in December, we expect an extra gain to come close to the upper boundary of our forecasted range of THB1.4-1.7bn.
- FY21 earnings growth still intact. In spite of the lower industrial land transfer prospects, we still expect FY21 earnings to grow by 24% YoY. In addition to the extra gain in 4Q21F, WHA's solid earnings base from the warehouse business will be another factor to support growth as the expansion of e-commerce has driven the demand for leased space for logistics and warehousing YTD. Note that WHA has large-scale logistics projects in the development pipeline. Management remains upbeat on the logistics warehouse business, and is maintaining its FY21F new leased spaces at around 175k sqm.

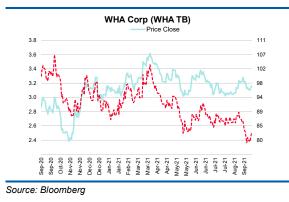
